

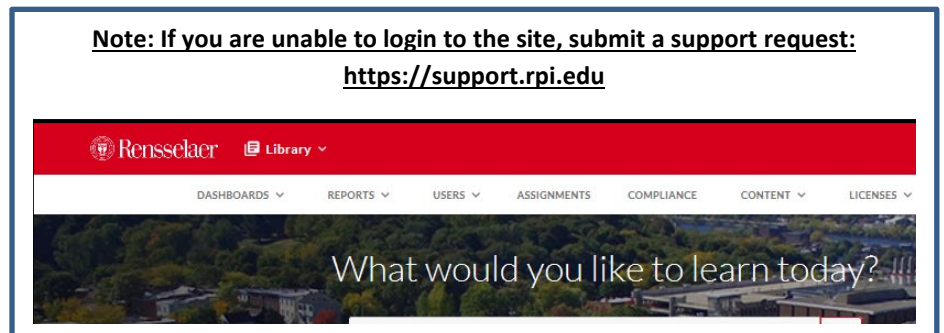
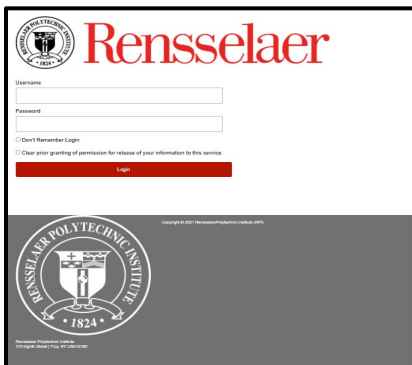


# Rensselaer

## Rensselaer Manufacturing and Prototyping Lab Safety Orientation in Percipio Login and Completion Instructions

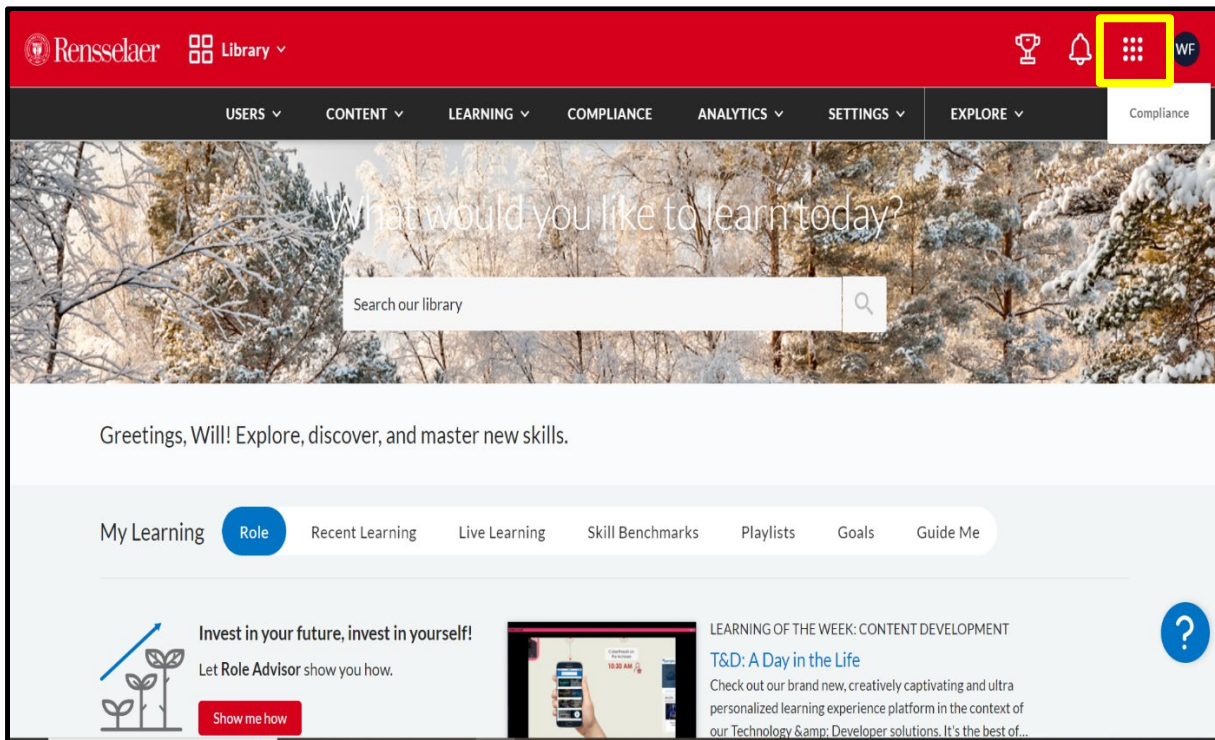
**Step #1:** Go to <https://rpi.percipio.com> (Also available from RPI Info page)

**Use your RCS credentials and DUO App to login through the “single sign on” feature of Percipio.**



**Step #2:** Once you are logged into Percipio, select the “Compliance” app from the dotted grid in the right hand corner of your screen




**Step #3:** You are now in Percipio Compliance. You will most likely see two carousels. The top carousel contains compliance courses that are “assigned” to you and require completion. You should see the “Rensselaer Manufacturing and Prototyping Laboratories-Safety Orientation-4.0” listed here.

The modules are listed in alphabetical order.
